

BOARD OF ALDERMAN MINUTES
Thiebaud Meeting Room
January 20, 2026
6:00 p.m.

The council met in regular session. The meeting was called to order at 6:00 p.m. by Mayor Hull. A silent prayer was observed followed by the Pledge of Allegiance. On roll call, the following members answered present: Curt Roland, Brian Griffith, Mike Main, Logan Powell, Nate Eddie, Harold VanDeMark, Judd Chesnut, and Colton Higgins.

Also attending, Mayor- Mike Hull; City Administrator – Rusty Rives; Assistant City Administrator – Bethany Aborn; City Clerk – Felicia Costley; Police Chief – Shannon Crouch; Fire Chief – Rick Heinen. City Attorney – Steven Kaderly was unable to attend this evening.

A motion was made by Alderman Powell to approve this evening's agenda. Alderman Griffith seconded this motion. On vote, all members present voted yes.

Alderman Main made the motion to approve the December 15, 2025, Regular Session Board of Alderman Minutes as presented to view ahead of time. Alderman Higgins seconded this motion. On vote, all members present voted yes.

In Public Good and Welfare, Jim Buzzard, Building Inspector, had two properties that were up for review. 1404-1410 Lexington, owned by Roger Mayfield. Photos shared by Jim showed that the area had been thoroughly cleaned. Mr. Mayfield was in attendance and shared that this property has a pending sale. Upon sale the pending order will remain. Jim would like to extend this order by four months to the May 18, 2026, meeting, giving the new owner a chance to fulfill the order. The plan is to rehabilitate and rent. Alderman Eddie made the motion to extend the order until the May 18, 2026, meeting. This motion was seconded by Alderman Main. On vote, all members voted yes. Chief Crouch let everyone know that to the credit of Mr. Mayfield, once the eviction was resolved there have been no abatement issues with this location.

807 Poplar, owned by Martin Hohulin. This property is on its 120-day review. The garage has been demolished. The area above the porch still has deterioration. This home is inhabited. Jim Buzzard recommends extending this order a couple of months to the meeting on March 16, 2026, to see some more progress made at this location. Alderman Griffith made the motion to extend the order until March 16, 2026. This motion was seconded by Alderman Chesnut. On vote, all members voted yes.

1503 College, owned by Mike Sims. After Jim Buzzard's presentation and discussion, a motion was made by Alderman Higgins declaring the location to be a public nuisance and detrimental to the health, safety and welfare of the residents of this city. This motion was seconded by Alderman Eddie. On vote, all members voted yes. Alderman Roland made the motion that an order be issued to repair or demolish and remove the house

structure. This motion was seconded by Alderman VanDeMark. On vote, all members voted yes.

Jim was asked about New Seasons. They have six properties that really need review. The old O'Sullivan building demo is complete. They are starting to fill-in the buildings in the back.

Police Chief Crouch discussed the police reports. These reports were posted online for the Aldermen to view ahead of time.

Fire Chief Heinen discussed the Fire Report. This Fire Report was presented ahead of time for the aldermen to review.

With the Treasurer's Report being presented ahead of time for members to review, Alderman Griffith made the motion to approve. Alderman Main seconded the motion. On vote, all members present voted yes.

General Business:

Mayor Hull presented Council Bill No. 1968 **AN ORDINANCE OF THE CITY OF LAMAR, MISSOURI TO AUTHORIZE THE CITY ADMINISTRATOR OF THE CITY OF LAMAR FOR TRUMAN AREA TRANSPORTATION (TATS) TO APPLY FOR FEDERAL FINANCIAL ASSISTANCE ON BEHALF OF THE CITY OF LAMAR AND TO EXECUTE ANY CONTRACTS(S) RESULTING FROM SUCH APPLICATION FOR ANY GRANTS BETWEEN THE CITY OF LAMAR AND THE MISSOURI HIGHWAYS AND TRANSPORTATION COMMISSION AND THE AREA AGENCY ON AGING PROVIDING FOR CAPITAL, OPERATING, AND/OR MARKETING ASSISTANCE,**

COMPRISED OF FEDERAL FUNDS TO BE EXPENDED FOR COMMISSION-APPROVED TRANSIT PROJECTS.

This bill being furnished in advance for all aldermen prior to the meeting was read by title only for the first reading.

Alderman Chesnut made the motion to approve this bill. Alderman VanDeMark seconded the motion. On roll call, all members voted yes.

This bill being furnished in advance for all aldermen prior to the meeting was read by title only for the second and final reading.

Alderman Powell made the motion to approve this bill. Alderman VanDeMark seconded this motion. On roll call, all members voted yes.

Therefore, the Mayor declared said bill had been duly adopted and numbered Ordinance No. 1950. The ordinance was signed and approved by the mayor and attested by the city clerk and the Seal of the City affixed thereto.

Mayor Hull presented Res No 535 ***A RESOLUTION OF THE CITY OF LAMAR, MISSOURI AMENDING OR REVISING THE 2025-2026 BUDGET, PARK FUND AND AUTHORIZING EXPENDITURES OF FUNDS.***

This resolution being furnished in advance for all aldermen prior to the meeting. Rusty explained that the heat exchanger is out. It will cost \$10,000 to repair the unit but then we are not guaranteed that it will work. This is a 35-year-old unit. It will cost approximately \$44,000 to replace the unit.

Alderman Eddie made the motion to approve the bill. Alderman VanDeMark seconded the motion. All members present voted yes.

With the passing of Res No 535 there was no further need for Res No 536.
