# VARIETY OF EVENTS

## January 2026

01/02/2026 Officers were dispatched to 29 SW 1<sup>st</sup> Lane for a theft in progress. The suspect was transported to the Barton County Jail pending formal charges.

01/08/2026 Officers were dispatched to the 500 block of Truman Street for property damage. The suspects had fled the scene before the victim contacted the Barton County Emergency Dispatch. Investigation continues.

01/09/2026 Officers located a subject in the 400 block of E 12<sup>th</sup> Street known to be a non-compliant sex offender. The male was arrested and transported to the Barton County Sheriff's Office. Charges were submitted to the Barton County Prosecutor.

01/09/2026 Officer was dispatched to the 500 block of West 10<sup>th</sup> Street for a peace disturbance report. Suspect was issued a summons for Peace Disturbance and one for Excessive Noise tires.

01/09/2026 Officers conducted a traffic stop on a vehicle after traveling the wrong way down the roadway. The 22 year old driver from Des Moines, Iowa, was arrested for driving while revoked and transported to the Barton County Jail where he was incarcerated pending formal charges.

01/13/2026 Officers seized plates from a vehicle they did not belong to. The owner of the plates was contacted and stated they would be by to collect them on a later date.

01/13/2026 Officers were notified of a theft from a motor vehicle that occurred in the 1500 block of Broadway. The victim stated that a purse has been stolen out of her vehicle. The suspect has been identified and officers are actively working the case.

01/16/2026 Officers conducted a traffic stop for an equipment violation. A 46 year old Lamar resident was arrested for driving while revoked. The individual was placed on a 24 hr hold pending formal charges.

01/20/2026 Officers conducted a traffic stop. During the stop, officers conducted a probable cause search of the vehicle and located marijuana and drug paraphernalia. The K9 did not alert. After conducting the search, nothing else was located. The driver was given a warning for equipment violation and a warning for marijuana.



01/29/2026 Officers were dispatched to a domestic disturbance in the 400 block of W. 17<sup>th</sup> St. After investigation, a criminal summons was issued to one of the parties for Domestic Assault 4<sup>th</sup> degree.


